Dear Colleague:

Thank you for maintaining your investment in organized dentistry and your commitment to strengthening our profession. With your support, the American Dental Association (ADA) will remain the largest and oldest dental association in the world.

The Pennsylvania Dental Association (PDA) and ADA are your legislative advocates, the voice for your practice in Harrisburg and Washington, DC. PDA and ADA are also your reliable source for information and communication of issues that affect your dental practice.

On September 15, the State Board of Dentistry (SBOD) voted 6-4 to proceed with regulations expanding Public Health Dental Hygiene Practitioner (PHDHP) practice site locations to include childcare settings, physician offices and residences of homebound and hospice patients. PDA communicated its opposition to the regulations a number of times, citing concerns about patient safety and the need to ensure that patients receive comprehensive diagnoses and treatment from dentists. PDA volunteer leaders attended several SBOD meetings and presented testimony urging the SBOD to carefully assess issues such as standards of care, infection control compliance and patient safety.

Prior to the SBOD meeting, PDA's lobbyist and staff met with House Professional Licensure Committee (HPLC) staff to discuss concerns about expanding practice locations for PHDHPs. HPLC staff noted PDA's concerns about the PHDHP referral process with dentists and the need for dentists to examine and diagnose patients. PDA will continue to lobby HPLC members and staff, as well as the SBOD, Governor's Policy Office and IRRC as the regulations move through the regulatory process.

It may take two or more years before regulations are enacted, so PDA will use every opportunity to amend the draft, with particular attention paid to the referral process, scope of practice in these settings, the role of physicians and liability. PDA's Government Relations Committee will also review the adequacy of current educational and training requirements for PHDHPs to determine whether additional requirements are needed to ensure patient safety and appropriate standards of care.



We Advocate for Your Profession

PDA's Legislative Priorities

PDA is the premier dental organization at the forefront of legislative initiatives to improve the dental practice environment in Pennsylvania for both dentists and patients. The legislative session, which commenced in January 2017, allows PDA two years in which to advocate on members' behalf for important insurance reforms, and scope of practice and access to care initiatives. PDA's priorities for the 2017-18 legislative session include:

- Assignment of benefits
- Health practitioner student loan forgiveness and tangential loan mitigation issues.
- Increased funding in the Medical Assistance program for dental providers.



EPA Amalgam Separators Final Rule

The Environmental Protection Agency issued a final rule requiring the use of amalgam separators in dental practices nationwide. The rule went into effect on July 14, 2017, but the compliance date for most dental offices will be July 14, 2020. There are exemptions for certain dental specialties, dentists who do not place amalgam (and only remove it in emergencies), mobile dental units and offices that do not discharge wastewater into a Publicly Owned Treatment Works. Offices that already have separators installed will be grandfathered in for up to 10 years.

PDAIS is in the final stages of acquiring a contract with a vendor that will provide discounted separators to PDA members. Look for an email announcement about the vendor in late November.

There will also be recordkeeping and other best management practice requirements; offices will be mandated to submit one-time reports noting compliance with the rule. Please contact Kathleen Bumpers at **kek@padental.org** with questions.

PDA Achieves Legislative Milestone: Assignment of Benefits Bill Takes First Step in Legislative Process

PDA has lobbied for years for the passage of assignment of benefits legislation, which would require insurers, on patients' request, to assign benefits directly to dentists, even if they are non-participating providers. On October 24, PDA accomplished a monumental task while contending with intense opposition from insurance lobbyists. The Senate Banking and Insurance Committee passed SB 373, PDA's assignment of benefits legislation, with a vote of 9-6. SB 373 moves to the Appropriations Committee for consideration, then the full Senate for a vote. Your state legislators need to hear from you why Pennsylvania should pass assignment of benefits legislation. The voice of organized dentistry is thousands strong, and represents both dentists and patients. Act 124 Compliance Opioid Continuing Education

The General Assembly passed legislation that requires the following of health care providers:

- Dispensers and prescribers applying to **renew their licenses or certificates** must complete at least two hours of CE in pain management, identification of addiction or the practice of prescribing or dispensing of opioids as a portion of the total CE required for biennial renewal.
- Applicants for an **initial license** must obtain at least two hours of education in pain management or identification of addiction, and at least two hours of education in the practice of prescribing or dispensing opioids. They may complete this requirement as part of their professional degree educational program or from a continuing education (CE) program taken within 12 months of obtaining an initial license or certificate.

PDA has obtained clarification from the Department of State's Bureau of Professional and Occupational Affairs (BPOA) about exemptions in Act 124 for health care providers who do not prescribe controlled substances. BPOA confirmed that there are two **exemptions** for licensees:

- Licensees who are exempt from the federal Drug Enforcement Agency's (DEA) requirements for a registration number.
- Licensees who do not use the registration number of another person or entity, as permitted by law, to prescribe controlled substances in any manner.

The continuing education (CE) requirement applies to all licensees who have a current DEA registration or use another DEA number (as permitted by law) to prescribe controlled substances. **The CE requirement is effective for 2019-2020 licensure renewal.**



PDA is offering a 4 hour course that will meet the requirements for initial licensees and those seeking renewal on Friday, April 27, 2018, as part of Pennsylvania's Dental Meeting in Hershey. PDA will announce dates and locations as more courses are scheduled for 2018.
